## SwissCommunity: Organisation of the Swiss Abroad

The Swiss Society of New Zealand
Incorporated, as the umbrella organisation of
the Swiss Clubs in New Zealand, was officially
recognised as a Swiss Society by the Swiss
Community. We completed a declaration
that we would notify the Swiss Community if
any of the following eventuated:

- -less than 50% of our members are Swiss citizens.
- -the majority of office holders are NOT Swiss citizens.
- -the President of our Society is NOT a Swiss citizen.

# Membership policy

All citizens of Swiss origin in New Zealand and their descendants shall be eligible for membership of the Society. Children up to 18 may participate in Society sporting activities if their parents are members.

Persons who are not Swiss citizens or descendants, but who have an affinity to Switzerland or Swiss people may be eligible for membership by special decision of the committee. They shall have all the rights, including voting, of ordinary members but may not hold office in the Society.

### **Financial requirements**
